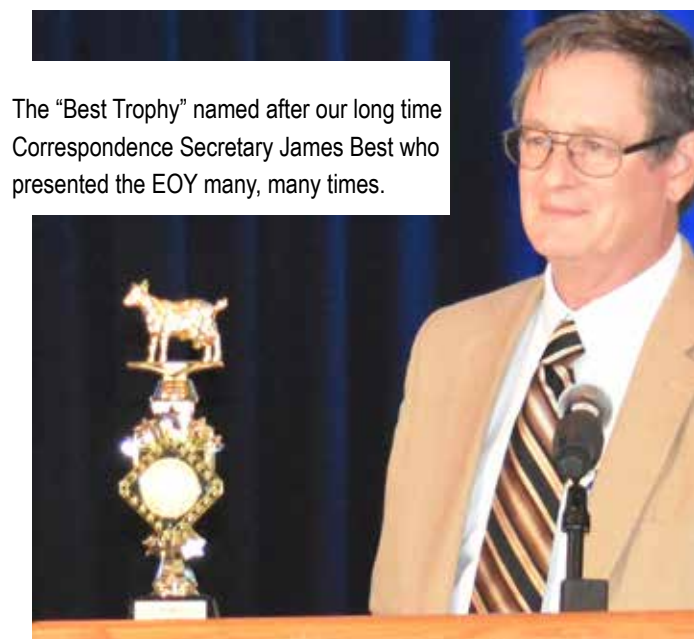

First, I hope this finds everyone healthy and safe. Next, I want to congratulate NCHEA on a great live, in-person Annual Conference.

It was great to see everyone, the education was first-class, and the awards banquet entertainment was fun! Way to go!

Speaking of annual conferences – ASHE held their first live, in-person Annual Conference in two years! We had a great turnout with over 2,000 attendees. The Exhibit Hall was busy and full of energy, yet was spacious enough for adequate distancing among attendees. There was excellent education, with some speakers from our own state of North Carolina. A total of 12.5 CECs were available. We had a great Region 3 networking hour on Sunday afternoon, and it was wonderful to see everyone! There was a very positive response about the host city, Nashville, TN, with many comments requesting that the Annual Conference be held there again soon! Note that the Virtual Annual Conference is being held September 15-17, 2021. It will have new and different education sessions (and a few from the live conference) with a low cost to attend and 19 more CECs to obtain!

The ASHE Board held our third quarter meeting in Nashville in the days just prior to the conference. Many things were discussed including welcoming a new chapter – The Wyoming Society of Healthcare Engineering (WSHE). We also spent a lot of time reviewing our mission, vision, strategic imperatives and the future vision of healthcare with the purpose to update and revise the current master plan which was last updated in 2018. There will be more to come on this – stay tuned!

During the past 18 months, we've learned the importance of providing education in all formats to meet our members' needs. I'm impressed with the way ASHE, its faculty, and so many of you who serve as subject matter experts, came together to develop and deliver dozens of webinars, quick trainings, online courses, YouTube training videos, and virtual instructor-led trainings when it wasn't possible to hold

in-person education. Our goal is to continue to support your education needs virtually, in-person, and through on-demand programs and resources. Keep an eye out for the newly updated Health Care Construction Workshop online course that will be released right after the Annual Conference. And check out the education offerings page on the

ASHE website for upcoming programs.

ASHE continues to work with AHA in responding to the President's infrastructure package. ASHE advocated for a funding package including \$58 billion for potential emergency preparedness spending. ASHE is still working to find funding to cover \$390 billion in deferred maintenance in healthcare and is working hard to ensure that any infrastructure package includes funding for hospital physical environment.

Code Wins: Over 600 code changes occurred that ASHE was involved with. These changes either reduce burden or appropriately and cost effectively enhance patient care spaces since the 2012 editions of the codes.

The COVID Response Tactics Survey (CRTS) measured our response to the pandemic and will help prepare us for responding in the future. The ASHE CRTS has been recognized by the National Institute of Health (NIH) - National Disaster Research Program as the appropriate benchmarking method for the disaster and will be used as the standard method. In other words, ASHE set the standard.

ASHE is also setting standards when it comes to sustainability. ASHE is now the Energy Star Partner of the year for five years in a row! Data collected by our Energy to Care dashboard was successfully used to advocate for reducing potential burden on healthcare. Through collaboration and thought leadership, ASHE has been able to establish the scoring baseline for Energy Star certification for hospitals and MOBs.

A BIG thank you to all the ASHE affiliated chapters. The ASHE/chapter relationship is very important to our profession and our advocacy efforts.

Thanks to each of you for what you do every day – you make a difference!!
