Our recent NCHEA sponsored CHFM (Certified Healthcare Facility Manager) and CHC (Certified Healthcare Constructor) exam prep classes held in Concord on September 29 and 30 were well-attended by both full and associate members. We had a total of 41 members who checked in out of 50 who signed up. One of the 2022 goals was to increase the number of NCHEA members who have the designation of CHFM and CHC. This is a prestigious certification and one that takes experience and knowledge in the related field. The NCHEA theme this year was around meaningful educational offerings, and this event is an example of the successful year we've had in all the districts and at our Spring Seminar and Annual Conference.
